



## WHOLESALE CLUB APPLICATION FORM (continued)

**I hereby apply to become an Eniva Wholesale Club (EWC) Member, defined herein as "Eniva Member, Member, or (EWC) Member," I understand & agree:**

1. I am of legal age (18 years or older) and reside in the state in which I enter this application. I further understand this Application will be processed by Eniva when all information on this form is filled out and verified.
  2. I shall become an Eniva (EWC) Member upon acceptance of this application by the company in accordance with the company's Membership Plan and Policies and Procedures. As a Member, I understand I WILL RECEIVE: wholesale Member prices on Eniva products, receive a one-time \$9.70 shipping credit on first Eniva product purchase, receive a \$10 credit (must call in to redeem) in my member account to be used toward my second Eniva product purchase of \$19.95 or greater (\$10 credit expires after 45 days & restrictions may apply if combined with a pre-existing product specials), receive a Member packet which will include additional information and offers, receive the ability to participate in the Eniva Customer Rewards program, receive Member product offers and information and have the opportunity to participate in online (world wide web) Member activities.
  3. By virtue of this completed application, I give Eniva Corporation permission to send me periodic communications via mail, email and phone. If I prefer not to receive these communications, I will contact Eniva Corporation Member Services.
  4. The Application becomes effective upon acceptance of the Application by Eniva, signed or over the phone. At that time, Eniva will assign a unique Member Identification Number which must be used in all official business correspondence and contacts with the company. Eniva allows only one position per person. This may be one SSN or EIN, but not multiple entities or combinations of entities.
  5. As a new Eniva Member, I understand Eniva products are not intended to diagnose, treat, cure or prevent any disease.   10. I will not use the Eniva's products, programs and company names in any advertisement or promotional material not pre-approved by Eniva in writing.
  11. By virtue of this completed application, Eniva Corporation has permission to re-use, publish, reproduce and distribute to the public any comments, testimonies, recordings, appearances, photographs, and any other medium, in conjunction with name if applicable, ("items") which have occurred as a result of your association with Eniva. Eniva Corporation is released and held harmless from any and all liability associated with or as a result of using these items. You may not be able to inspect or approve Eniva's finished use of these items. If you do not want these items used by Eniva Corporation, you must notify us in writing within 10 days of your application.
  12. Inventory loading or encouraging of inventory loading is strictly prohibited. NOTE: Upon resignation, a (EWC) Member may return unopened, unused product, that has not reached its expiration date (excluding shipping, handling and any applicable sales tax) for a 90% refund (except for special promotions, special pricing, and free product) within 12 months of becoming a Member.

13. Should I choose to participate in the Eniva EWC "Thank You" Program and/or Marketing/Compensation Plan Program, I understand the following:
    - 13.1 Eniva Members are independent contractors and are not purchasers of a franchise. This Application is not intended nor shall be construed to create a relationship of employer-employee, agency and members, partnership or joint venture between the (EWC) Member, sponsor and/or Eniva. (EWC) Members have no legal right or authority to bind Eniva to any obligation.
    - 13.2 I understand that if I fail to make a qualifying monthly purchase I will forfeit my commission check for that month as well as other possible Marketing Plan Benefits. To qualify for commissions, and advancements, I must fulfill published personal requirements including but not limited to 49 BV points per month for (EWC) Member/Manager and Area Manager, 74 BV points per month for Regional Manager, Executive Regional Manager, National Director, Executive National Director, Regional Vice President and National Vice President.
